

# Kayak Storage Passes

The Town of Cape Carteret offers kayak storage racks for use by residents and property owners at the Anita Fort Drive, Holly Lane, Bayshore Drive, and Manatee Street water access parks.

A kayak storage pass is required to store kayaks at these facilities, and can be secured at Town Hall during normal business hours or by completing the online form below. Town staff will verify residency or property ownership prior to issuing kayak storage passes.

There is a \$25 annual fee for kayak storage passes, which are valid from now until December 31, 2024.

4. I understand that the term of the Kayak Storage Facility rental is for one year, not pro-rated. If I choose to remove my kayak from the Kayak Storage Facility prior to the years end, a refund will not be issued for the remaining time of the rental agreement. I understand that it is my responsibility to store my kayak upside down and firmly secure my kayak to the rack. I further understand that it is my responsibility to display the rental decal on my kayak while it is in storage at the Kayak Storage Facility as to not incur a fine for failure to display a current annual pass.
